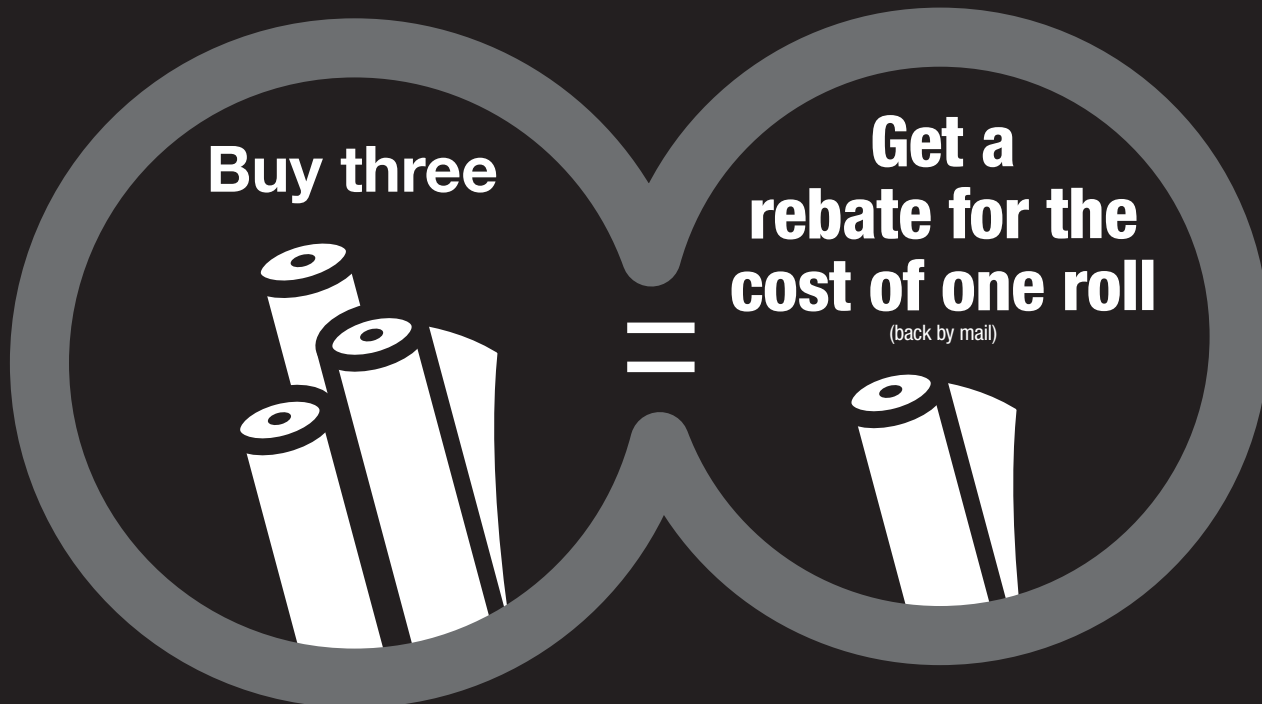


Mail-in rebate
